Opening Remarks from the Chair and Vice Chair

Clara Lajonchere, PhD

- Chair Lajonchere thanked Director McCall for her years of service and forward-thinking direction of CIAPM.
- Praised the cutting-edge nature of California research and innovation as a testament to the existence of the program and the work to promote the projects of the program with other state agencies, in concert with other advocates such as Secretary Figueroa.
- Looks forward to the opportunities for growth at CA Health and Human Services Agency (CalHHS) and praised the Administration's commitment to maintaining CIAPM's budget despite state-wide budgetary reductions.

Keith Yamamoto, PhD

- Vice Chair Yamamoto continued the appreciation of Director McCall for her direction and vision and energy for the CIAPM goals. Allowed CIAPM to engage at the forefront of bioscience.

All amendments were approved unanimously by the Council, effective immediately.

Major Program Updates

- 1) Budget and Scope -- Statutory Transition to California Health and Human Services Agency (CalHHS)
 - CIAPM's enabling statute was expanded to emphasize **pandemic research**, should additional funding become available, and transition program to CalHHS.

• CIAPM is considering potential philanthropic partnerships as a pathway for increased funding capacity and impact for depression research across California.

2) Exploring the Possibility of Philanthropic Partnerships for Depression Research

- Current Status:
 - Thought Partners at State Level: Governor's Office and Mental Health Services
 Oversight and Accountability Commission (MHSOAC)
 - MHSOAC supported Depression RFP listening sessions in Summer 2023.
 - Part of MHSOAC's Strategic Plan is to establish an innovation fund. CIAPM has met with MHSOAC to learn more about their approaches, including how CIAPM growth and philanthropic support is in concert with how state addresses mental health.
- Questions for council members:
 - **Q)** What organizations, philanthropic, advocacy, industry, etc. do you recommend CIAPM consider inviting to discuss strategies to address depression? Must keep in mind CalHHS approval of philanthropic activities.
 - **A)** Corporate support is readily available via Foundations, beyond what the corporate goals are; center integration and innovation in the program pitchina.
 - i. May need to segment potential funders as individuals vs. pharma and technology vs. healthcare and service providers.
 - ii. California vs. National funders and identify what the stakeholders are looking for to drive interest, perhaps a subcommittee within our program.
 - iii. Advisory boards at institutions are one network to tap to justify engagement and philanthropic interest.
 - iv. Affinity group Grantmakers in Health.
 - v. School Healthcare Associations may also show interest.
 - vi. Some Community Based Orgs. are also grantmakers.

- **Q)** Do you have experience with public-private partnerships or philanthropy that might be useful for CIAPM in this context?
- **A)** Resources, and data access is one leverage point for conversations with philanthropic partners, potentially at CalHHS
 - i. Datasets at CalHope.org, CIAPM may have better internal access to teams after move to CalHHS

Representative Research Collaborative

1) Project aims

- Over five years, develop a network with government agencies at state and local levels, as well as with communities and universities, to disseminate NIH *All of Us* information.
- Grants <u>may</u> be competitively awarded to advance strategies of community engagement in under-resourced areas of California.
- An evaluation process will be conducted at the end of the program, followed by the
 possible development of guidance for other state or local governments to engage with
 AoU in similar capacities.
- Planning is underway: We have met with independent *All of Us* teams in California and at NIH to develop work plans and strategies for both participant outreach and researcher outreach.

2) Milestones: March - July 2024

- Workplan has been refined by NIH
- Further planning We regularly meet with All of Us teams in CA and NIH
- Designed initial CA-specific outreach assets (English and Spanish)
- Initial meetings to gather advice:
 - Visited and networked with the All of Us Journey Mobile Outreach (San Jose and Modesto)
 - o Central Valley Community Foundation
 - Valley Children's Hospital
 - O Southern California All of Us Consortium
 - Coast to Coast All of Us Consortium

3) Next steps: July - September 2024

- Continue to build the Representative Research Collaborative, starting with public agencies.
 - O Develop outreach materials specific to potential partners across state and local government in California.
 - o Coordinate an outreach strategy for fellow state and local government agencies.
 - Engage potential partners.
- Assess evidence-based engagement strategies to plan tailored outreach approaches.
- Design an approach to engage more researchers in utilizing All of Us data.
- Develop a framework for a future guide for other state or local governments to follow CIAPM's model and contribute to All of Us

Federal Engagements

- 1) National Academies of Sciences, Engineering & Medicine (NASEM)
 - Government-University-Industry-Philanthropy Research Roundtable (GUIRR)
 - CIAPM was the only entity representing state government at the Summer GUIRR Meeting
 - GUIRR may consider developing a branch focused on state government crosssector partnerships
 - O CIAPM would likely be invited to support such an effort, most likely in an advisory role

2) Advanced Research Projects Agency for Health (ARPA-H)

- CIAPM participated in the SDSU-hosted ARPA-H Summit on Health Care Equity and Access in April for Minority-Serving Institutions of Higher Ed
- O Discussed ideas of public agency partnerships with four Program Managers
- Met U.S. HHS Secretary Becerra, who wishes to be updated about CIAPM's efforts
- O Roundtable discussion with ARPA-H Director and senior leaders about equity
- O CIAPM is facilitating connections between ARPA-H Program Managers and state health data officials to explore potential partnerships
